 In consideration of the acceptance of my participation in this activity, I agree to save harmless and keep indemnified the British Federation of Pedal Car Racing (BFPCR), the event organisers and the owners of the venue and their respective officials, servants, representatives and agents and any other participants from and against all actions, claims, costs, expenses and demands in respect of death, injury, loss or damage to the person or property of myself howsoever caused, arising out of or in connection with my taking part in this activity and notwithstanding that the same may have been contributed to or occasioned by the negligence of the said bodies, their officials, servants, representatives or agents.  
 I accept that I shall be solely responsible for any decision as to my fitness to participate.
